E. CITIZEN REMARKS & PRESENTATIONS

Supervisor Medlin asked if there was anyone present to speak to the Board on an item not listed on the agenda.

1. American Red Cross – Executive Director of Mid-South Chapter

Mr. John Brown, Executive Director of the Mid-South Chapter of the Red Cross, commended DeSoto County for their action after the January 11, 2020 tornadoes. He stated they have 51 cases opened as a result of the storms. Mr. Brown stated they hope to host a preparedness workshop in conjunction with EMA to prepare volunteers and the community.

Supervisor Medlin asked if the Red Cross helped with temporary housing. Mr. Brown stated they work with partner agencies to meet that need.

Chief Olson stated EMA has a great partnership with the Red Cross. He stated they had a shelter training class just last Friday before the storms hit.

Supervisor Gardner asked who some of the partner agencies were. Mr. Brown said they work with Habitat for Humanity, 8 Days of Hope, Samaritans Purse, and others. He stated every agency has to address the temporary housing bridge.

Supervisor Medlin stated this is his 29th year on the Board of Supervisors; and he was out with road crews in 1994 after the ice storm, in 2011 in Lewisburg after the tornado, but he was most proud of the employees this year. He stated the Road Department has done an excellent job and he has heard a lot of compliments on them. He said he has never seen people pull together like they have recently. Supervisor Medlin said he was out at one of the burn sites over the weekend and the Road Department employees were doing a great job. He also commended the Sheriff's Department for their work.

2. Holly Springs Road Segment 1 Award

Mr. Tracy Huffman stated they received 3 bids:

•	Talbot Brothers Contracting Co., Inc	\$20,472,509.88
•	Dement Construction Co., LLC	\$21,664,766.35
•	L&A Contracting Co.	\$27,037,173.62

He noted the low bidder for the base bid plus option 1 and option 2 was Talbot Brothers Contracting. Mr. Huffman stated the bid included 2 options with option 1 being the sub-base as clay gravel material and option 2 being the sub-base as crushed limestone material; and once the bids were received it was recommended to select option 2.

Mr. Huffman stated the engineer's estimate was \$17.7 million. He said the low bid is about 15% over estimate; but, based on reasons outlined in the bid evaluation and given they had 3 bidders, he is recommending awarding the bid to Talbot Brothers.

Mr. Huffman stated he is asking for any additional BUILD or other grant funds to be awarded to DeSoto County for Holly Springs Road, but didn't believe they would be available for this segment.

Supervisor Gardner said the Board has been talking about this for over 8 years, and it is finally happening. Mr. Huffman stated this is Segment 1 and noted that Segment 2 is in the design phase. Mrs. Lynchard commended the Board for saving the one mill mandatory in fund 002 for Holly Springs Road. She said she is hopeful that 2020's collections will replace the money spent on the overage.

7. Storm Recovery Update

a. Update from EMA

Chief Chris Olson, EMA Director, gave a timeline of the storm warning.

January 11, 2020 12:09 – Tornado Watch (this had been building up for days)

Two waves of storms

3:45 am – Thunderstorm Warning in Southwest portion

4:05 am – Thunderstorm Warning in Northwest potion

4:16 am & 4:28 – More thunderstorm warnings in 3 different areas 4:45 am – Tornado Warning in Love area – EF1 – 100 mph winds

5:05 am – Tornado Warning in Lewisburg area – EF2 – 120 mph winds

5:45 am – All warnings were over

Chief Olson stated the response from citizens, volunteer fire department, city fire departments, and Sheriff's Department was overwhelming. He stated they handed out 215 work orders to the different volunteer organizations that came in to help and most of them are still working and plan to stay through this week. He stated the man hours logged have been incredible. A list of organizations:

Knights of Columbus Gulfport – Jerry is here managing volunteers Church of Latter Day Saints – 10 work orders/9 completed 8 Days of Hope – 53 work orders/8 completed MS Baptists – 57 work orders/10 completed Samaritans Purse – 87 work orders/37 completed 215 total work orders handed out – trying to help citizens at no cost

Chief Olson stated Red Cross served over 1500 meals and snacks and gave out over 100 emergency kits. He noted the next step is the declaration process with MEMA and the damage assessment numbers have been submitted to MEMA. He said they will bring in the Small Business Administration who will offer lower interest rate loans to help people rebuild. Chief Olson said they hope to hear within a week about federal assistance that will be available.

Supervisor Lee asked if MEMA had to make personal contact with all the victims. Chief Olson said they wanted to, but some of the work had to be visual. He noted that using Crisis Track, they field officers would enter information on their phones and it was kept up with at the EOC.

Mrs. Stephanie Hanks stated New Prospect has taken the supplies from the Lewisburg Fire Station and they are open Tuesdays, Thursdays, and Fridays for storm victims to come and get supplies and good. She stated they have been feeding the MS Baptist Disaster Team.

Sheriff Rasco stated Officer Ray Henley had information from the Sheriff's Department. Officer Henley stated taking care of the citizens is their number 1 priority. He said there are officers in several areas to keep looters out and to keep people from going through the curbside items. He said they will keep running the report on storm relief until they are told to stop. Officer Henley said they are still working traffic control for Entergy and the Road Department on Allison Road. Chief Olson said they have some time on that and they are gathering numbers as they go. Supervisor Lee said to make sure all the entities helping know to turn in their man hours.

Supervisor Medlin stated that the volunteers needed to park someplace and carpool in to keep private vehicles off the road. Officer Henley said they did ask some to do that over the weekend and he said the deputies were transporting some volunteers to help with the traffic. Supervisor Medlin said the private vehicles were keeping the Road Department from getting to the debris piles in some instances. Chief Olson said the Sheriff's Department was good to clear an area whenever they called them.

b. Temporary Burn Site & Disposal Totals

Environmental Services Director Ray Laughter stated MDEQ has approved a temporary burn site at 399 Laughter Road South and he presented documentation to that effect. He said the Road Department has really gotten after the cleanup. He noted that they have so far taken 390 loads to that site and there have been no complaints about the smoke. Mr. Laughter said some people have called and asked if contractors could take vegetation to the burn site. He said MDEQ does

not have a problem with it, but it could affect federal funding for debris management. Road Manager Robert Jarman said the site was not set up or safe for public use. He said they are running in and out one truck at a time and the Road Department is using their radios to monitor the flow of trucks.

Supervisor Medlin said some of the contractors might also be charging. Mr. Laughter said he told one contractor he could not dump free if he was charging to haul off the debris. He said so far no one has argued.

Supervisor Gardner said some contractors are helping people for free and piling the debris on the road. Mr. Jarman said they have had only a few issues where contractors are loading on trucks and dumping at the road. Supervisor Gardner asked if the debris had to be on the right of way during the emergency declaration. Mr. Nowak said it did not for storm debris under the emergency declaration. Mr. Jarman said he is asking the contractors to have the landowner call in and confirm if they are doing it for free.

c. Emergency Purchases

Mr. Jarman introduced Blake Haas as the new County Engineer.

Mr. Jarman gave out a list that Procurement produced showing the emergency purchases. Mrs. McLeod stated Mrs. McNeil is keeping all the emergency purchases in a folder and she made the spreadsheet. Mr. Jarman noted that every time they buy something related to storm damage, they are putting 'emergency purchase' on the purchase order. He noted a few of the larger purchases:

- 4 inch rock & hauling
- Grapple buckets for skid steers
- Chain saws
- Machine rentals
- Contractors hauling debris

Mr. Jarman stated he took the time to get two quotes on the over \$5,000 items. Supervisor Gardner asked if the items got on the inventory. Mr. Jarman affirmed and said they took the time to weld inventory plaques on the grapple buckets. He stated some of the old chain saws were in bad shape; and FEMA will reimburse for new ones, but not to repair the old ones.

Mr. Jarman stated he hired a contractor to help on Allison Road & Bethel Road to help get the debris out so the power trucks could get in. He said the contractor is running 2 trucks and working with the Road Department crews.

Supervisor Gardner asked Mr. Jarman to confirm that the Road Department is running all 8 of the County's limb trucks and he has outsourced some pick up. Mr. Jarman affirmed. Supervisor Gardner asked about the rest of the County. Mr. Jarman said the rest of the County needs to get picked up. He said they are currently running about 15 trucks per day and that Tate County has offered to send 6 limb trucks today to help.

d. Debris Removal

1) 3440 Fir Drive, Olive Branch

Supervisor Medlin stated Fir Drive is right of way that was set aside on a plat, but the County never did accept the road. Mr. Jarman stated the landowner cannot cross a ditch to clear the trees on the other side of his property and they are requesting a temporary culvert to allow them to get back there. He stated the ditch runs along the County's right of way; and Mr. Scott Young recommended a 12-inch culvert. Mr. Nowak stated there would have to be a finding that the culvert is was necessary to prevent the spread of disease of a health hazard.

Supervisor Medlin said the area is behind the home and the only way to get to it is across the ditch on the county's right of way. He said if a culvert is not temporarily put in, they will tear up the county's road getting equipment in to do their debris cleanup, and water may back up to the road causing road damage or road flooding.

Supervisor Jessie Medlin made the motion and Supervisor Lee Caldwell seconded the motion to allow for a temporary culvert to be put in the right of way by the County finding the action to be necessary to protect the integrity of the road and the road right of way, to assist in storm debris removal, and protect the health and safety of the public and authorize the Road Manager to get pictures of the site to bring back to the Board.

2) 342 Dixie Hills Drive

Mr. Jarman said he met with the landowner at 342 Dixie Hills Drive and a ditch comes alongside of his property that is the center of a dedicated right of way. He said the right of way is on the plat, but no road is planned. Mr. Jarman stated the County did some repairs to the ditch last year because trees were in it and not letting the water flow. He stated the storm has got trees down all along the ditch which will hold water and not let the ditch flow properly and will end up flooding the road like it did before the County made the repairs last year.

Supervisor Medlin asked if the drainage easements had trees in them, could the County go in and clear the trees to protect the road and ensure the flow in the ditches. Mr. Nowak said the statute says you can clear debris to protect the community at large. Supervisor Medlin said if the flow of water was stopped there would be other health problems and mosquitos as well.

Supervisor Michael Lee made the motion and Supervisor Jessie Medlin seconded the motion to authorize the Road Department to clear the ditch at 342 Dixie Hills Drive based on the allowances in the MS Code 33-15-49 and finding that the ditch not flowing affects the health and safety of the citizens and to protect the integrity of the County road and to assist in storm debris removal.

3) Allison Drive

Mr. Jarman informed the Board that there is not much water flowing where the County installed the new box culverts on Craft between Allison & Bethel. He said there are a lot of trees in the ditch between Craft & Hwy 305 that are blocking the flow. He noted that Cane Creek is also very bad.

Supervisor Lee asked Mr. Jarman to contact the Corps of Engineers or NRCS for help with some of these ditches. Supervisor Caldwell stated the Corps of Engineers has a group that takes care of those things.

Supervisor Denison asked Mr. Jarman what his plan of action was. Mr. Jarman said chainsaws and track hoes and his crew. He said there is really no other way.

Supervisor Medlin stated the box culvert is in 6-foot sections and if they don't get that ditch cleared that debris will jam up in the box culvert and cause the sections to shift and the road to fall in.

Supervisor Denison asked Mr. Jarman what his overall plan was. Mr. Jarman stated Fir Drive can wait, at Dixie Hills they can get the stumps out of the ditch and go back later for the trees. He said the Craft Road ditch is the biggest. Supervisor Lee said the Corps may have equipment the County does not have to help with that one as it is a main flow route.

Supervisor Medlin suggested Mr. Jarman go out and look at all the ditches, evaluate them, and make a plan. He said some will be more critical than others.

Supervisor Lee said the County was already addressing the main drainage ditches before the storm; and now there is a whole new need to clear them.

Supervisor Gardner said EMA can take out their drone and get some good footage of the main ditches and tributaries.

Supervisor Michael Lee made the motion and Supervisor Jessie Medlin seconded the motion to allow the Road Department to start cleaning up the most time sensitive areas and contacting homeowners to keep them informed of the work based on 33-15-49; clearing any tributary the Road Manager deems critical and bring the non-critical list back to the Board; contact the Corps of Engineers and NRCS for their help and finding that the ditch not flowing affects the health and safety of the citizens and to protect the integrity of the County road and to assist in storm debris removal.

Mr. Jarman said if the County got the federal declaration, they will be allowed a lot more leeway. He said he hopes to learn more at a meeting with FEMA tomorrow.

e. Quotes for Limb Removal

Mr. Jarman stated he asked 4 companies for quotes and 2 declined. He stated the two quotes he got were:

- Michael's Tree & Loader Service \$8.25 CY limbs, \$8.95 CY mixed
- B&P Services \$14.00 CY

He stated Michael's Tree & Loader Service can pull about twice as much as the County trucks, and he is FEMA certified and inspected. FEMA says they don't do their paperwork by truck yardage, they estimate the percentage of debris in the truck.

Mr. Jarman stated he has Superintendent Michael Brown at the burn pit estimating yardage and the rubbish pit is also estimating yardage. He stated they are trying not to put debris in the landfill and they are taking most of it to the burn pit. He stated root balls and stumps are going to the landfill. Mr. Jarman stated they are trying to get the loose, small debris out and go back for the stumps later. Supervisor Medlin said he would like for them to burn as many stumps as possible.

Supervisor Medlin asked if a contractor was necessary and expressed concern that the large trucks could not get around in the hard hit areas. Mr. Jarman stated people are putting debris on the road as fast as they can pick it up and his concern is that he is tying up all the limb trucks. He said the entire county had strong winds and there are piles all over the County that need to be picked up. Mr. Jarman said he would like to run the normal routes to get caught up. He noted he is not opposed to limiting the time for a contract, but he thinks he needs someone to help get them ahead of the debris pickup for a short time.

Supervisor Medlin asked if the contractor would take debris to the burn site. Mr. Jarman said he would like them to take their loads to the burn site and the County trucks can pick up mixed debris to take to the landfill. He said he will concentrate on the hardest hit areas with the contract work.

Supervisor Lee asked if Mr. Jarman could go back to the high bidder and allow them to haul at the lower bidder's price also. Mr. Nowak stated under the emergency conditions they can do that. Mr. Jarman stated it is easier to manage only one contractor, but he will do that if it seems necessary.

Supervisor Medlin asked Mr. Jarman to be sure the contractor did not line up several trucks and block the road. Mr. Jarman said they have talked about that and also talked about a flagger.

Supervisor Michael Lee made the motion and Supervisor Mark Gardner seconded the motion to approve contracting with Michael's Tree & Loader Service, LLC under the authority of Miss. Code. Ann § 33-15-17, as they had the lowest quote; to authorize the Road Manager to offer other contractors to haul at the lowest quoted price at the discretion of the Road Manager; and authorize the Board President to sign the agreement with Michael's Tree & Loader Service.

Supervisor Caldwell stated the Armory has now found an area off Star Landing close to the mobile home park for the National Guard's temporary parking lot. She said the ball fields will move back to the west side as requested. No Board action was required.

H. NEW BUSINESS

1. 9:30 a.m. - Second Amendment Support

Mr. Steve Gay stated he was here to urge the adoption of the 2nd amendment sanctuary resolution. He stated he has lived in DeSoto County for 25 years, his wife Nelda is a lifelong resident, and they raised 3 children here. He noted he is NRA pistol certified to teach classes.

Mr. Dana Criswell, Representative District 6, stated he is here more as a citizen. He thanked the Board for taking this stand and noted several citizens came in order to support this resolution and ask the Board to take a stand. He stated it is somewhat symbolic and they want to head off anything coming to Mississippi like what is happening in Virginia. He said he is proud of DeSoto County.

Supervisor Medlin asked if the State Legislature is bringing up anything. Rep. Criswell said he is bringing something forward in the House and Senator McLendon is in the Senate. He stated it is a resolution making the same promise to back the National Guard and State law enforcement.

Mr. George Roser, local real estate broker, stated he lives in Olive Branch and works in Hernando. He stated the 2nd amendment has nothing to do with hunting, but has to do with tyranny especially from our own government. He said there is a "red flag law" being presented that if a neighbor accuses you of being unsafe, you can have your guns taken away.

Mr. Mark DuBois stated he has spoken with Supervisor Gardner who was concerned over the word 'sanctuary'. He said he did not want to concede that sanctuary means one specific thing, but a broad thing.

Supervisor Gardner said he is a strong proponent of the entire bill of rights, not just the 2nd amendment as is the entire Board. He said he raised his hand to uphold the constitution; and he is not conceding, just clarifying. Supervisor Gardner said he is a Hunter Education instructor and a concealed carry proponent. He said when he spoke to several law enforcement officials and attorneys and said the word 'sanctuary' their thoughts immediately wet to harboring illegal aliens. He said the Board of Supervisors takes a stand to make DeSoto County a safe place for those who want to exercise freedoms under the 2nd amendment rights. Supervisor Medlin agreed and said everything you hear about 'sanctuary' is about illegal aliens.

Supervisor Caldwell asked Rep. Criswell what his opinion was. Rep. Criswell said he likes the word 'sanctuary' because it would join with other states. Supervisor Caldwell asked if 13 states

had adopted this. Rep. Criswell said there were 13 states and over 100 counties. He stated what is really important is the resolution and backing what the resolution supports. He said he would defer to the Board with the wording they chose to use. Supervisor Gardner agreed that the resolution is excellent and suggested some alternate words for 'sanctuary' such as refuge, haven, safe haven, harbor.

Supervisor Lee Caldwell made the motion and Supervisor Mark Gardner seconded the motion to establish DeSoto County as a 2nd amendment safe haven county and authorize the Board President to sign the resolution stating such.

3. Census 2020 Outreach Plan

Mr. Rob Winkler said Mrs. Lynchard asked him to put together an outreach plan and that it is really 2 components. He stated the Census Bureau is in the process of hiring temporary positions and in a couple of months will be mailing the census forms. Mr. Winkler stated the County will assist the Census Bureau in publicizing and making people aware of job opportunities through the Census Bureau and to help generate interest in completing the census.

Mrs. Lynchard stated the County is doing anything they can to create awareness of how the census is important to the future of the County. She said at this point the objective is to let people know about job opportunities by working with the newspaper and others, posting on the County website and posting on social media. She stated they have thought about putting a computer in the rotunda downstairs to help people apply for the census jobs. Mrs. Lynchard stated Mr. Winkler is doing a great job heading up all Census-related activities for the County. Mr. Winkler stated that the County participates in several data programs in which the Census Bureau periodically sends requests to the GIS Office to verify boundary delineations and addresses as well as provide addresses for new homes that have been built.

Supervisor Medlin asked if the County did have a recruiting event if someone from the Census Bureau would be here. Mr. Winkler said it was not likely, but they would have materials from the Census Bureau available. Mrs. Lynchard said they will certainly ask the Census Bureau to send someone.

Supervisor Gardner asked how the County was getting the word out. Mr. Winkler said they have not done any promoting yet. Mrs. Lynchard stated the Census Bureau has benchmarks. She said the first one was validating data; and now they are moving into the outreach phase to recruit workers. She said they will be reaching out on all of the County's social media, newspaper, senior groups, colleges and the County website.

IT/GIS Director John Mitchell stated a big part of the task was to come up with a plan. He stated today's effort is to present ideas and get the Board's input and blessing. He said they want to be sure people know it is not the County hiring and people have to go to census.gov to apply.

Supervisor Caldwell asked what the timeline was. Mr. Winkler said they have just started recruitment efforts to hire works and the main window of time for the survey to go out is April 1, 2020. He said the time frame to complete is end of April. He noted they are actually doing the census now in Alaska because of their weather.

4. DCRUA – Permission to Construct Sewer Line Along Vaiden Road

Mr. Bill Austin, Executive Director of DCRUA (DeSoto County Regional Utility Authority) stated they need a new pipeline for the new Lewisburg Area School. He stated it is very important that they get underway immediately in order to get the line built in the timeframe the school needs.

Mr. Huffman stated the school will have a pump station. He said this would be a pressure line with limited abilities to connect. Mr. Huffman stated given the cost and time frame this is a more efficient solution.

Supervisor Gardner asked how much more a gravity line would be. Supervisor Denison (former DCRUA Board member) stated the cost was \$15 million more. Supervisor Gardner asked if this was a one-customer shot or if others could subscribe to the service. Mr. Huffman said it is difficult to say, but they will try to have at least one connection point along the line. He said the possibilities will be limited.

Supervisor Caldwell asked if DCRUA had permission from MDOT. Mr. Huffman stated they have discussed with MDOT but would have to submit a permit request.

Supervisor Gardner asked if other lines were existing there. Mr. Huffman stated there are gas lines on the north side of Vaiden and they will survey and try to miss existing lines. Supervisor Gardner said with plastic pipes and no tracers they are going to hit water lines. Supervisor Medlin said the water lines are also on the north side.

Supervisor Gardner asked for the total numbers. Mr. Huffman stated it is about 4 miles. Supervisor Denison said they looked at 3 alignments and this one afforded more opportunities for people to potentially tie into. Mr. Huffman said that is correct to a limited degree. Supervisor Denison said this was the least expensive option. Mr. Huffman stated the cost is about \$5.3 million.

Supervisor Medlin stated that was a long way of useless line down Highway 305 because the land is not buildable. Mr. Huffman stated there would be some ways to connect at the end of the line. He stated they hope to use the County's prescriptive easement/right of way. He stated they

would ask permission to work with the Board Attorney on using County easements and right of way.

Supervisor Gardner asked if the school was a mega campus in 20 years similar to the others if a 12-inch line would handle the school and other customers. Mr. Huffman stated the School Board had 2 major schools planned, but now they have pulled to just a middle school. Supervisor Lee stated there is not enough land there for a high school. Supervisor Gardner asked if it was really a good deal to build a \$5 million sewer line to one school.

Mr. Jarman stated the concern from the Road Department is if the County decides to widen Vaiden.

Supervisor Lee asked if DCRUA had any plans to help with money for a line down Byhalia. Mr. Huffman stated there are plans for a gravity line that connects along Camp Creek from Byhalia Road to Short Fork WWTF. Supervisor Lee asked about the option of going down Holly Springs Road and 305. Mr. Huffman stated that is a longer route, more expensive and not timely.

Supervisor Medlin asked if DCRUA had looked at a temporary lagoon. Mr. Huffman stated they did and they are looking for a long term option. He said a lagoon requires constant upgrading and maintenance.

Supervisor Gardner said he knew that DCRUA spent a lot of time in Washington asking for federal funds and it seems like there is a lot of advantage to having a gravity line in that area. Mr. Huffman stated the potential for growth is there; but it is hard to justify spending \$15 - \$20 million without a customer base in place.

Supervisor Denison stated the underlying issue in the whole thing is it is not an ideal location for amenities where the school is going. He said he thought the Board should have some conversation with the School Board in future selection of sites to discuss sewer, road, water, etc. Supervisor Caldwell said they have asked the superintendent that before and thought it was going to happen. She said they told him they were doing things backward and need to put together a plan first.

Supervisor Medlin said the Board of Supervisors gets involved after the fact when they need a road. He said he spoke with some school board members and the superintendent and told them that highway gets closed because of high water and that is not good for a school.

Supervisor Denison said it did not make sense not to have a collaborative effort. Supervisor Caldwell agreed and said this Board has tried.

Mr. Austin stated the DCRUA Board spent the better part of 2 meetings coming up with a reasonable route.

Supervisor Michael Lee made the motion and Supervisor Lee Caldwell seconded the motion to give DCRUA permission to construct a sewer line along Vaiden Road as presented, authorize the Board Attorney to work with them, with this approval conditioned on the construction costs to be borne by the School Board.

5. GIS – DCRUA Mapping Project

Mrs. Lynchard stated a couple of months ago DCRUA asked the County to participate in a mapping project. She stated the Board authorized GIS to work with Mr. Huffman to figure out a scope of work and bring back a report.

Mr. John Mitchell stated they came up with a way to meet what DCRUA needs with a minimum impact to the County as far as cost. He stated they would need an MOU between the County and DCRUA to move forward. Mr. Mitchell stated the project would give DCRUA a system where all their information is mapped; line, pump stations, etc. He said GIS already has some of that information that the utilities have given. He said anytime someone is willing to give GIS data, they put in a layer on the County's mapping system.

Mr. Mitchell said DCRUA does not have a digital representation of what they have and they all thought this would be a good opportunity for the County to have some useful information as well as help DCRUA out. He stated it actually goes along with another project GIS is working on to map out all the County buildings. Mrs. Lynchard asked what DCRUA is asking for. Mr. Mitchell stated the County currently has a GIS site and company online site. He said DCRUA will do all the work and the County will give them access to storage. He stated the County does not pay for the storage site as if is given to the County by ESRI because the County buys maintenance. He stated the County is not currently using the storage space. Mr. Mitchell stated he wants there to be an understanding that if the storage starts costing, DCRUA will bear that cost.

Mr. Huffman stated they will be taking live data from the DCRUA system and putting it into GIS. Supervisor Medlin asked if the DCRUA Board was okay with paying if it comes to that. Mr. Huffman stated they have a budget line item for information technology.

Supervisor Michael Lee made the motion and Supervisor Lee Caldwell seconded the motion to authorize GIS and DCRUA to work together and allow Smith Phillips to work with them to prepare an agreement and if there are future costs, DCRUA will pay them.
